Jim,

See email below from RW. On certain issues this negotiation drifts from the "difficult and costing the taxpayers' money" box into the "showing the potential customer scant respect" box.

It goes without saying that our team (including Dennis) who have delivered 5 successive versions of the milestone schedule have gone out of their way to accommodate the BBS requirement to stay cash neutral. It is also entirely competent – they are all experienced professionals and not daft laddies who have never done this before. Despite repeated requests the guys have had no feedback whatsoever since Gary Dalton declared himself generally unhappy with all aspects of it in the last week of March (which was in itself several months into development of the schedule with BBS). I will not recommend anything which is materially different to what we already have other than the spreading of individual milestones causing BB concern - which we have repeatedly invited them to do.

Never mind – a more serious and practical issue is that I am required to report to Transport Scotland on any potential material changes to the shape or terms of the milestone payment curve in the context of profiles we have already provided for them. This is critically important at TS Board level as Ministers are keen to see budgets met and these are currently set for the next 2 years. We can't leave TS or CEC exposed to cash flow requirements they have not budgeted for and to preserve the credibility of **tie** I will need to brief on the reality that Bilfinger Berger are at this late stage seeking to further front load the payment schedule notwithstanding the huge initial milestone payment (20% of contract) which as we know I have spent months getting Transport Scotland (and they in turn Audit Scotland) comfortable with. I wonder what the payment terms are on the M80 job?

We will also require to appraise Transport Scotland on the position in respect to funding drawdown, and I would be grateful for your view on the status of the contract close position.
