Cllr Mowat -

I met with Mr & Mrs Taylor this morning and covered the following:

## SITE PROGRESS

I advised on the overall programme. I described the reinstatement process. Outside their home the noisy work is complete - cutting, pecking, removal of debris. Reinforcement bars are in one track and the relatively quite work of compression chamber installation and concrete pour will take place over the coming weeks. However no cutting has taken place on West Maitland Street as this is a different track design and will not require remedial works. The contractor has applied for extended working hours the coming two Saturdays 1pm to 5pm but may not necessarily be working directly outside the Taylor's home.

## COUNCIL TAX REBATE

I advised that I had discussed their wish for a Council Tax rebate with Revs & Bens yesterday and relayed that: Council tax pays for all Council services and these have continued to be provided during the course of the Trams project

Council tax is based on property value and this has not been affected by the Trams project I passed them the contact details for Revs and Bens if they wished to raise a formal appeal. [Alan - as per our discussion yesterday they may be in touch]

## REFUSE

In addition to the Taylors, Ann Moffat at 6A has complained of rats and I was approached by Jane Hudson Price at 8A as I was photographing the bins who also complained about rats

There are 10 palladin bins at their stair door comprising - 5 x Shanks, 2 x Oran, 2 x CEC, 1 x William Tracy Domestic waste bags should go in the CEC bins with trade waste in the others.

Efforts will be made to see if there is a better location for this number of bins away from the flat frontage but still accessible.

Logistics is the company employed by the Trams project to deliver goods from delivery vehicles to shops. They have as an 'add on' to their work agreed to lift traders refuse bags and put them in the bins but cannot handle burst bags. They have assisted by putting domestic bags that have been dumped around the bins.

Perhaps there are not enough CEC bins or the pick ups need to be more frequent or residents need lettered to remin d them to put bags in the bins not around the bins?

Traders may need lettered to remind them they should put bags in the bins and not rely on the good nature of Logistics.

As the Trams project comes to it's conclusions stakeholders may need reminding of what waste removal procedures will take over once the construction is complete and the streets opened up again.

## **PARKING**

The creation of a City Car Club parking space and the loss of residents parking spaces means the Taylors feel they should get a refund on their parking permit. Post meeting I checked and phoned Mrs Taylor leaving a message with the relevant person to contact

[Gary - you may be contacted by them. Heather Shields in Parking recommended you]

The Taylors are clearly at the end of their tether having endured many, many months of disruption. My efforts at this meeting can be likened to trying to put a sticking plaster over a crack in a dam that has gushing from it a huge amount of pent up frustration and exasperation. They considered the meeting a waste of their time. I undertook to take up their issues with the relevant parties, hence the material above.


I have been contacted by Mr and Mrs Taylor of 4/2 Grosvenor Street regarding the noise from the tramworks on Shandwick Place. I have asked a Council officer to take a noise measurement from outside and inside their flat to measure the noise which they are experiencing and which is apparent from a phone call to the property.

It is obviously hugely disappointing that the work has had to be redone on Shandwick Place and whilst I understand this has to be done to ensure that a fit for purpose tramline is handed over to the Council I have every sympathy for Mr and Mrs Taylor who have endured months of disturbance from the tram works and are now faced with this incredibly noisy work when they believed (as we did) that the very noisy work was finished. They have also had to live with increased rubbish, dirt from the works and general disturbance for a considerable amount of time and we have not offered them any rebate on council tax or anything to mitigate the upset to their living conditions. Whilst they will benefit from living very near a tram stop I'm not sure given the quality of the public transport in the area that will be seen as a fair recompense for the disturbance. Given this additional work what can we offer in the way of rebate or compensation because I think something is required. Mr Taylor works from home quite a lot and Mrs Taylor is at home with their daughter —

school holidays begin tomorrow and to have your peace at home shattered by noise is, on a rainy day especially, is particularly difficult to manage.

I look forward to your speedy response.
