thank you for your reply and I hope you enjoyed your holiday.

Following on from the Tram Project Update meeting last night, I really think an urgent meeting to discuss the proposed next 18 months is vital.

There are two major concerns (over and above the daily annoyances) that have been raised already and answers appear to be lacking.

Timescales for the make up and distribution of maps were unacceptable and missed all of the festival visitors. Marketing and promotion - what is happening to help us, when and how much of a budget is left for us East End Traders? We have ideas and have passed/discussed these on but nothing positive is coming forward.

Timings of works - Now 7am - 10pm? - No one on the street that I have spoken to is willing to accept this if noise and light pollution beyond rush hour is advocated. We have also asked for a detailed schedule of when noisy and dirty works are due to happen.

Our Businesses and others around have been affected and the footfall has dropped significantly onto York Place. You have two fledgling hotels in the street whom when purchasing, designing and strategising their openings, did not have Tram Works in their sights. This is due to the Councils decision to put the end of the line on York Place at the last minute.

This disruption has harmed our reputation considerably and despite the fact that we have been perceived as Liars to our guests, there has been very little light at the end of the tunnel in terms of regulation and financial assistance to at least stop the rot.

This will result in job losses if we cannot trade professionally and profitably.

I do hope that you are able to at least take our concerns back to the Councillors and the Lothian Valuation Board when deciding on Rates Relief, Economic Development Budgets and marketing and promotion initiatives.
