Further to my email on Friday, I have completed the review of the proposed settlement agreement. It took longer than I thought but it runs to 80 pages and needed a lot of cross referencing.

I have attached a copy of my review. The first couple of pages are the most important but it is fair to say there are a number of gap items on key Schedules, especially in relation to ON Street and the fact that nowhere does it appear to tie back to the Lump sum price agreed for Airport to Haymarket or draw in an agreed programme. I don't think the Interface Agreement insulates CEC in the way the Principals discussed at Mar Hall.

I haven't analysed the Tram related documents in micro detail as I think it would be useful to go through these with Alastair Richards if you are agreeable. Let me know.

Happy to discuss at your convenience (I will be in the car from 0600 tomorrow morning UK time or call me any time before 12 tonight if that suits better).

I am back from leave and have read the proposed Settlement Agreement Eleanor forwarded last week, along with the Interface Agreement. There are a number of points to highlight, and I need to cross check a couple of items which I will do over the weekend. I will send you a summary (main issues only) by Monday morning.

On other issues, Susan and I had a constructive meeting today with Dave Anderson regarding the VR applications etc and we will be ready for a structured discussion with you on 18 July when you return. We will have briefed Dave on the direction of travel in a reasonable level of detail before he goes on leave on 15 July so we will have his comments for the 18<sup>th</sup> as well.

I have also worked through a number of TEL / governance items with Gregor (and Alan Coyle / Dave Anderson) for your consideration on the 18<sup>th</sup>.

I haven't noticed much improved behaviour from Infracore and in fact the Siemens on street proposal for the Target Sum merely adds back £14m they took out at Mar Hall to settle the Airport to Haymarket price. It is ridiculous and I have warmed up CEC regarding this just in case Colin thinks it is ok.
