My email to you was simply to note the two outstanding issues that you were dealing with as discussed with you on Wednesday night and consequently it was not necessary to copy Gary, Tom or anyone else into that note. It was for you to contact Gary and Tom in this regard.

Tom has not made any contact today and as it is now lunchtime on Friday I do not expect him to turn up today as promised. When can we close this?

Regarding the Milestones it is extremely concerning that despite three months of painstaking and careful consideration given to the production of the Milestone Schedule (now in its 6<sup>th</sup> draft) by tie most of which has been met by apathy from BBS, you now consider this to be a very complex project and careful consideration needs to be given to certain matters. This fact has never been lost on tie during the three months of production and your team are well aware that all of the matters noted by you, such as programme, areas and values have been given due and proper consideration in the current Schedule and we take exception to the inference that it doesn't. Indeed your appointed consultant QS has spent some time with us to understand the due process. No adverse comments have been forwarded. It was agreed two weeks ago that you would revert with your final proposed tweaks by last Wednesday and we still await this. Please advise on a precise date/time that this can be delivered.

This is a key commercial issue to be resolved prior to closing the Infraco Contract and we propose to raise this with the senior consortium members on Monday morning.
