Subject: MUDFA Alfred McAlpine Infrastructure Services (AMIS) – Contract A150 Pre-Construction Services (PCS)

I refer to our recent discussions, correspondence and submissions in connection with the above, and most recently on Monday 20th August 2007.

In recognition of the meeting scheduled for Friday 24th August 2007, AMIS MUDFA wishes to draw the specific attention of tie Limited to the following documentation;

 Report and Recommendation to the Limited for the Management of the Gateway between Pre-Construction Services and Construction Services, provided under cover of letter Ref; AMIS/tie/letter/AM/Project/101 dated 20th February 2007.

This submission, after a period of 26 weeks, has never been acknowledged or addressed by the Limited. Fundamental to the planned discussions of Friday 24th August 2007, it demonstrates the dependency and analogous nature of PCS with the sustainable and timely delivery of Construction Services under the MUDFA terms and conditions, i.e. Contract Objectives, Schedule 4 Rates and Prices, Value Engineering Incentive, Schedule adherence et al.

It also addresses the impact of Risk Management, Value Engineering and Early Warning of Potential Construction Delays, while identifying a Proposed Way Forward, an Action Plan for Success and a series of Critical Actions Key to Success. It is essential that the Limited provide a response or alternatively articulate other solutions for success.

All these dates are predicated on an "anticipated construction start date in January 2007", with a Contract award date of 1st June 2006; as the Limited are aware the eventual Contract award date was 4th October 2006 with a corresponding construction start date of 4th April 2007.

This summary table and objective evidence demonstrates, beyond all reasonable doubt, the MUDFA Contractor's input and interventions during PCS, within a clearly defined and demarcated framework with concise timescales and durations.

All IFC Drawings were to be issued before commencement of Construction Services, having been valued engineered and technically verified by the MUDFA Contractor, in accordance with the MUDFA terms and conditions, throughout the five month PCS period, as defined within the tile Limited approved PCS Programme.

It is a matter of record that the PCS was extended to six months, at the request of the Limited, on the 4th October 2006, immediately prior to execution of the Contract.

Therefore all impacts and dependencies are duly sanctioned, by tio Limited, as Employer, Project Sponsor and Project Manager.

The current recorded and factual delay in the availability of IFC Design and Design related information, based on the information provided by the Limited during the Tender / CARP process, ranges from thirty seven weeks to forty nine weeks accordingly.

As stated above and consistently advised by AMIS MUDFA to tie Limited, Pre-Construction Services was a critical deliverable and interface opportunity to ensure the safe, sustainable and timely delivery of Construction Services under the MUDFA terms and conditions.

Each and every contract requirement and obligation i.e. the Contract Objectives, Schedule 4 Rates and Prices, Value Engineering Incentive, Schedule adherence et al are all predicated and baselined on the comprehensive availability of detailed design for review, value engineering, technical and buildability input at the point of design maturity; all of which was to be complete prior to submittal to the Statutory Utility Company for detailed review and approval.

This process, together with the defined PCS inputs all form the basis of the MUDFA terms and conditions; these integral and dependent PCS deliverables are summarised below;

- Traffic Management and TTROs,
- Pricing and Cost Control,
- Advance Health, Safety and Environmental Planning,
- Stakeholder Management,
- Buildability Reports,
- Schedule 13 Requirements; and

This list is not intended to be exhaustive.

The attention of the Limited is also drawn to Part 5, A1 of the AMIS Tender submission that demonstrates the nature of the Buildability Report contemplated under Schedule One.

The breakdown of PCS, as a consequence of the tie Limited Project Management team allowing the design process to be delayed, has had a fundamental, significant and potentially unrecoverable impact on all aspects of the MUDFA terms and conditions, to the extent advised in letter Ref; AMIS/tie/letter/KAG/Projects/333 dated 3rd August 2007.

Please note AMIS MUDFA requires a detailed and substantive response to the above noted letter, in order to address and redress the contractual, commercial and operational frustrations prevalent on the Contract which are escalating as a consequence of the lack of response and reluctance to make appropriate decisions.

It is a matter of record that the Limited have not been forthcoming in the determination of key and critical decisions which has led to AMIS MUDFA into excessive correspondence.

	What, if any, are the obligations assumed or undertakings given in any Parliamentary Undertakings				
Response	The Parliamentary Undertakings which are relevant to the MUDFA Contractor are comprised in the MUDFA Contractor being obliged to comply with the Tram Legislation and to carry out and comply with the obligations set out in Schedule 13 (Third Party Agreements). Clause 2.5.3 is, therefore, not required and will be deleted.

Query:	Can you please clarify the process regarding issue, comment and programming of the SDS Provider's scheme design and detailed designs.					
	Schedule 1 Clause 2.34 indicates that all designs will be available for review during the Pre-construction Phase and that an Anticipated Final Account will be developed 4 weeks after the Effective Date (assumed to be 4 weeks after the start of the Pre-construction Phase?). However, Clause 2.3.10 under the Pre-construction Programme and Clause 2.7.16 under the Construction Programme requires us to develop programmes to ensure that " the SDS Provider's scheme design, detailed designs and construction production information are identified and defined in terms of content and timing". There appears to be some conflict here and we would be grateful if you could clarify the process. It would also be useful if you could provide an example of the level of detail that will be provided in the designs by the SDS Provider at the different stages.					
Response	The intention is to review the Anticipated Final Account periodically throughout the Pre-Construction Phase as the design develops. The initial review is expected to be carried out within 4 weeks of the start of the Pre-Construction Phase. By that time much of the detailed design will be complete. However, there will be further design development before issue of construction drawings which the MUDFA Contractor is expected to take account of in his Pre-Construction Programme in terms of its content and timing. It is possible that some of the planned design may carry forward to the Construction Period. This is now less likely given the new anticipated construction start date in January 2007.
