The Edinburgh Tram Project

Lead Replacement: Legal Obligation to Replace to Property Boundary

We refer to your letter references N348 and N351.

We note your letters detail SW's obligation regarding the opportunistic renewal of lead service pipes.

We have reviewed the scope of the Advance Diversion Works in terms of the Tripartite Agreement and the works specification (IFC drawings and schedules) and cannot find any agreement between the parties for CEC to carry out lead renewal works at it's expense. We note the measures required to be taken, with respect to Scottish Water's apparatus as a consequence of the Edinburgh Tram Project (major transport works), relate to the diversion of water mains and not to the upgrading of service connection pipes from lead to PE.

We request that SW review and confirm where CEC are obliged/have agreed to carry out lead renewal works to the property boundary at it's expense.
