Colleagues, you will have seen the papers on governance for last week's Board meeting. For those who could attend, the approvals requested were given by the boards. The completion of phase 1 of the reorganisation should be completed this coming week, subject to approval by the Council Policy & Strategy Committee on Tuesday 29th. Completion is also dependent upon finalising the composition of and appointments to the TEL Board, which must be concluded at the same time as the execution of the tie share transfer and related matters in order that there is no period when responsible Boards are not fully in place. Conclusion on the TEL Board composition, and as a consequence the TPB, is in the hands of CEC officials at present.

I had a session yesterday with the legal and tax advisers to nail down a few loose ends, none of which are concerning. One matter which has been nagging me is the proposed slimming down of the tie Board in parallel with the appointments to the TEL board. Although this is desirable to avoid unnecessary directorships, there are a couple of reasons why it may be better that the tie Board should remain intact for the time being. Firstly, the less overt change there is, the less scope there is for mischief from BSC. DLA have confirmed that the reorganisation creates no substantive risk to tie's contractual position,

but in the current atmosphere a challenge from BSC could emerge regardless of substance. Secondly, as the tax planning begins to take shape, the advice from PwC is that Board stability has some marginal advantage and avoids opening up a question from HMRC, even if again there is no substantive risk in the proposed slimming down.

Both sets of advisors concluded that a slimmed down tie Board was not a material threat so the decision is about shades of grey. Caution is probably the short-term watchword so my recommendation is that the tie Board should remain intact, subject to any individual decisions. This will <u>not</u> result in continuation of the current duplication of review and meetings, as the tie Board will still revert to a mostly statutory Board except where specific matters related to tie's contractual relationships require to be addressed formally. This is the position regardless of the tie Board composition. We can revisit the matter in the future, probably best at the time of executing phase 2 of the reorganisation which will bring LB into the corporate group and on the assumption that the BSC dispute is substantially resolved.
